BOTTLES AHOY!

The Internet may satisfy most of our needs to get a message "out there," yet this is no reason to abandon the old standby, the message in a bottle. Here are five occasions for which it may be best to cast one onto the waters of fortune:

Shipwrecked: Let's face it, Tom Hanks proved it can still happen. In his book, "The Twelve Million Dollar Note," Robert Kraske writes of many messages in bottles, including one that a Japanese seaweed collector found in 1935. It was from Chunosuke Matsuyama, who with his 43 crew mates had been washed up on an island ... in 1784. Now we know.



Under siege: In 2011, the crew of the Montecristo, a cargo ship, threw overboard a message in a bottle as they went into hiding when their ship was overrun by pirates. British commandos from two NATO ships found the bottle in the water before taking the ship and arresting the pirates. On the other hand, a WWI soldier cast into the English Channel a letter in a bottle, addressed to his wife. He died two days later. As reported by the BBC, the letter was found in time to be delivered to his daughter -- 2 at the time -- when she was 86. The letter closes: "Ta ta sweet, for the present. Your Hubby."

Fun: A message washed up in New Zealand after 76 years in the ocean, placed there by a Mr. Hillbrick in the 1930s, while on a cruise, and was returned to his grandson ... in Australia.

Romance: As reported in American Weekly in 1959, Swedish sailor Ake Viking cast adrift a note addressed "To Someone Far Away and Beautiful." Seventeen-year-old Paolina's father found the bottle in Italy and gave it to her. With the help of her parish priest, she was able to have the note translated and begin a correspondence. The Weekly concluded that the sailor Ake and Paolina, who had just turned 18, had "embarked on the sea of matrimony."

Iconic Building of the Month

The Australian National Maritime Museum does its job well. Though complex in design, there is a simplicity to the exterior that evokes the billowing sails of a ship. Standing at Darling Harbor in Sydney -- Australia's oldest city -- the Museum both symbolizes and exhibits the site's role as the cradle of the nation's maritime history.

Darling Harbor long served as an immigrant and commercial hub. It accommodated, too, the cargo transport demands of the railways of New South Wales, where it is located. Container shipping, however, proved too much, increasing the importance of Botany Bay and elsewhere. The area fell into disuse. Then came plans for the nation's bicentenary and a grant to revitalize the Harbor. Today, the Museum and Sydney Aquarium form a gateway to a recreational and tourist destination.

From inside, visitors to the Museum are able to see the port's activity through glass walls.



Designed by Cox Architecture, the vaulted ceilings and series of balconies allow for exhibits that range from the America's Cup yacht to model ships. Displays recognize the original occupation of the site by the native Gadigal people. Anchored nearby are several in-water museum ships, including the replica of HM Bark Endeavour, commanded by Lieutenant James Cook when he charted New Zealand and discovered the eastern coast of Australia.
